BY-LAW NO. 52-89

BEING A BY-LAW OF THE MUNICIPAL DISTRICT OF BRAZEAU NO. 77 RESPECTING THE GATHERING OF INFORMATION FROM OWNERS OR OPERATORS OF LICENSED MOBILE UNIT PARKS PURSUANT TO THE MUNICIPAL GOVERNMENT ACT, R.S.A. 1980 CHAPTER M-26, SECTION 236

WHEREAS, the Municipal Government Act, R.S.A., 1980, Chapter M-26, Section 236 provides for the licensing by municipalities of occupied mobile units; and

WHEREAS, pursuant to Section 236(8) of the Municipal Government Act (supra), a Municipality may by By-Law require the owner or operator of every licensed mobile unit park within the municipality to notify the licence officer in writing of certain information with respect to the mobile units in the mobile unit park; and

WHEREAS, the Council of the Municipal District of Brazeau No. 77 now wishes to pass a By-Law pursuant to Section 236(8) of the Municipal Government Act (supra) to require the owner or operator of each licensed mobile unit park within the Municipal District to notify the licence officer of the information required pursuant to Section 236(8) of the Act;

NOW THEREFORE, the Council of the Municipal District of Brazeau No. 77 hereby enacts as follows:

1. Definitions

In this By-Law:

- (a) "ACT" shall mean the Municipal Government Act, R.S.A. 1980 Chapter M-26 as amended.
- (b) "LICENCE" shall mean a mobile unit licence issued pursuant to the Act and the regulations under the Act.
- (c) "LICENSED MOBILE UNIT PARK" shall mean any mobile unit park within the boundaries of the Municipal District which contain one or more mobile units which are required to be licensed pursuant to the Act.
- (d) "LICENCE OFFICER" shall mean a person appointed by Resolution of the Council of the Municipal District as a licence officer for the purposes of Section 236 of the Act.
- (e) "M.D." shall mean the Municipal District of Brazeau No. 77.
- (f) "OWNER" shall mean any person who is in lawful possession of a mobile unit.

2. Licensed Mobile Unit Park

- (a) The owner or operator of every licensed mobile unit park within the M.D. shall:
 - (i) notify the licence officer of the M.D. in writing of the name and address of the owner of each mobile unit in the mobile unit park within fourteen (14) days of the mobile unit being occupied; and
 - (ii) notify the licence officer of the M.D. in writing of any change of ownership or occupancy or any removal of a mobile unit from the mobile unit park within fourteen (14) days of the change or removal.

3. Penalties

- (a) Any owner or operator of a licensed mobile unit park in the M.D. who fails to comply with this By-Law is guilty of an offense and is liable upon summary conviction:
- (i) for a first offense, to a fine of not more than ONE HUNDRED (\$100.00) DOLLARS;
 - (ii) for each subsequent offense to a fine of not more than FIVE HUNDRED (\$500.00) DOLLARS.

4. Effective Date

- (a) This By-Law shall be effective upon the date of its final passage.
