BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BRAZEAU NO. 77, IN THE PROVINCE OF ALBERTA, TO ESTABLISH A SCHEDULE OF FEES.

WHEREAS, the Municipal District of Brazeau No. 77 deems it expedient to set and review, as necessary, from time to time various fees of the Municipality; and

WHEREAS, in accordance with the Municipal Government Act, Chapter M-26.1, RSA 1995 and amendments thereto, the Council for a Municipality may set fees for goods or services provided.

NOW THEREFORE, the Council of the Municipal District of Brazeau No. 77, in the Province of Alberta, duly assembled enacts and adopts the Schedule of Fees, attached to and forming Schedule "A" of this Bylaw; and


THAT, this Bylaw shall come into force and effect upon the date of final reading being granted by the Municipal District Council
