She sees changes happening with it. The community wants this to be paved. Buck Creek seems to be dead and nothing has been happening with Buck

Creek. They do not have walking paths, or covered skating rinks, and have been pushed in the dark. Our councillor needs to do more. She spent three hours getting a petition. This road is high maintenance according to maintenance staff. Last year the road was unpassable. It has now become a haul road. She asked Sara how would she find it to be a safe road? The County is constantly redoing dust control. There are now three pits at the end of this road. It is not safe. There have been many people walking since COVID. Last year it was dusty. The cost to maintain that road is high. The school bus stops and there are safety concerns with gravel trucks on the road. It is a dangerous situation. The corner is bad needs to be brushed, but nothing is happening. Everyone forgets Buck Creek. She suggested Sara to come out there and see what they are dealing with. Recreation is a concern with traffic of holiday trailers accessing the river. She asked Sara to drive down there in the summer to see the people in RVs and that's where Council needs to do something with it for the safety. She stated she has been asking for 50 years. Bart was still in diapers when they were campaigning for this and Sara wasn't even thought of. She has also talked to Anthony about this many times.

Councillor S. Wheale spoke to the upgrades she has requested of Council for the Buck Creek area including SB90 dust suppressant and that many things were rejected by Council due to the decreasing of funding. She stated that there is infrastructure in the County that is failing, and that she would love to spend money in Buck Creek; however, it is difficult when there is failing critical infrastructure in other areas of the County.

Rita Skinner asked to give them a little bit, to maybe do the bridge, not the road. They County would be saving a lot more money on TWP 480 and it is not only the costs but the safety. The road is just terrible and ripply, the County needs to something before there is a lawsuit.

Estimate of labor

March 15,16, 2015 work on property to mitigate resultant flooding with placing County sandbags to west of basement window. Hours of floodwatch . 2 adults x4x\$20=\$160

Reseed at three weeks and continue watering and spread more topsoil. 6 X \$20 = 120

Leveling and returning stone to firepit 8 hrs of 4 laborers 4x 8 x 20 = \$640

Total= \$9325.00

Loss of income

This will be represented by the times that we as Chiropractors had to close our office to attend/present/and meet with county representatives. This includes 3 times presenting to the SDAB, 2 times presenting to council, meetings with the previous CAO and directors. There were 5 occasions that our clinic was required to be closed and income lost.

Loss of peace and quiet enjoyment

Allowing an industrial size development in a residential area brings with it an industrial maintenance and disruption to our previous quiet and enjoyment. One example of this occurred Mother's Day this year with a skid steer all day spreading gravel and creating dust and noise for 4 + hours such that we were not able to have an outside Mothers Day Dinner. Skid steer has happened on numerous occasions. for numerous hours, all during the day when you would hope to use your property for personal use and are unable to due the unacceptable noise.

We invite you to come out now that it is dark and see the extremely bright flood lights on this industrial shop illuminating our residential lot and home.

Mental anguish and personal injury:

Consequential to the flooding onto our property in April Tim was required to shovel a path to direct the flooding water away from the house on several occasions. There is an inherit risk of falling in these circumstances. On Saturday April 14, 2018 such an incident occurred where Tim fell onto the handle of a shovel. He experienced a sharp lancinating pain with an audible crack. For the next week he had to sleep in a modified position and work in a modified way for managing the fractured ribs. Our family has altered many travel plans especially when heavy rain has been in the forecast and there has been many sleepless nights especially when it rained or during spring melt since the shop development 4 years ago.

Water Easement

The modified surface and re-direction of water from its natural course onto our property from the adjacent property was done without our permission or consent. The front of our property was repurposed as a floodway for the water from the adjacent property and our driveway culvert was repurposed as a water regulator with a greater area of a property used as a flood area to control the water.

The county paid the engineer to testify at the SDAB \$215 / hr for 60 hrs plus mileage. This is $216 \times 60 = \$12,900$. The county essentially paid this engineer to advise a group of my piers that there was no way that water flood onto our property. And that the water issues were from our own property. In other words the testimony submitted and paid for by the county to SDAB was that we were misreporting our observations. The county inferred to the SDAB that our accounts were fraudulent . The County therefore by presenting us as fraudulent to a group of our piers has caused defamation of character. We as community members are particularly offended at this inference and techniques that the previous admin has used.

Here are the receipts for the site grading work on our lot recently completed October 2019.

We have still included estimates of labor of our family members. Many days and hours of their summers for the past years have been lost to making our home safer from flooding from the adjacent shop development. We would expect that some compensation would only be reasonable and fair. I suppose fair is not the correct word because nothing about this experience with Brazeau County has been fair. We continue to live next to an industrial shop with the included resultant water runoff, noise and now light pollution. Our requested labour requests are incomparable to what Brazeau County paid a Sameng engineer to testify against us.

We are still awaiting a response from our May 9, 2019 email to you in regards to the culvert upsizing recommended by Amec and Sameng that we were told would be done the summer 2017.

RE: Flooding of LaForest property from adjacent lot

We have been awaiting a response as per our meeting Friday May 18, 2018 in regards to our latest flooding (April 14, 2018) from water flow from the adjacent property.

We have reviewed the recent FOIP that we requested and find it's read quite interesting. A point that stands out to us is that one action taken by Director of Public Works and Infrastructure () was initiating an investigation that we were within

"the conditions approved by the SDAB in 2017 for works permitted that were to be undertake by Mr Leforest on his property"

Public works employee Lloyd Woloszyn (Sun. April 15, 2018) reported to him (that the owner of the adjacent property was going to run a razor to get the water flow to the culvert. Instead we observed 24 hrs after our call to Marc Gressler and you returned a phonecall that afternoon (Sat April 14, 2018) - that a very large truck with a high suspension was used to drive up and down the swale to open a greater path for the water to flow to the culvert on our property. It is important to note that the water flow over the next 4 days was great enough that it continued to top over the swale on the adjacent property and our recently constructed windbreak that slowed the flow of the flooding water towards our residence. See attached pictures.

Out of being curious we requested from county the cost of the Sameng drone study and the engineer's testimony at the SDAB hearing. Not including all other expected expenses at an SDAB, the cost of Sameng's opinion was over \$36,000. Previously, council approved an AMEC land survey study for an estimated \$53,735 plus GST in September 2014. The first drainage study, AMEC, was approved and completed after the shop permit was approved and shop and grading was completed summer 2014. The second study, a drone study by Sameng(completed Nov 2016), was completed after substantial drainage modifications were done to direct further water away from the shop and parking lot and large driveway to our home, the summer of 2016.

Without hearing from the County its course of action we have hired a contractor to commence work on our property and have rented equipment as well. We continue not only to incur significant work expense and labor and obvious mess in our previous professionally finished acreage. We continue to incur significant flooding water onto our property and significant risk to our residence.

A further point of clarity is that permission or consent was not obtained by Brazeau County or the adjacent property owner to permit the increased amount of water flow and volume onto our property. Water that is consequential to the development changing direction of water flow with grading, extensively modifying to the lands surface and surface area by changing grassed area to gravel, and the shop and shops concrete pad.

Once again we are pleading with Brazeau County to define a course of action to resolve the flooding on our property caused by the adjacent land owners development as previous courses and plans have been ineffective and continue to leave us not only at risk but at a greater risk of flooding.

TERMS AND CONDITIONS OF TAX RECOVERY SALE

Each parcel of land offered for sale at the public auction will be subject to a reserve bid. Reserve bid values are available from the Brazeau County Finance Department. The Purchaser will acquire the land free of encumbrances, subject to those exceptions listed in the *Municipal Government Act* S. 423(1).

The properties will be sold strictly on an "as is, where is" basis. Brazeau County makes no representation and gives no warranty as to the adequacy of services, soil conditions, land use zoning, building and development conditions, absence or presence of environmental contamination, or the developability of the subject property for an intended use by the Purchaser.

Terms: Purchase price payable by non-refundable deposit equal to 10% of purchase price due at the time of auction, with the balance of the purchase price due in 15 days. Payments by cash, bank draft or certified cheque only. Purchase price includes all taxes, fees and charges accrued to Closing Date. Purchaser responsible for payment of all taxes, rates, charges, and fees for the property after Closing. Brazeau County may, after the public auction, become the owner of any parcel of land that is not sold at the public auction.
