They indicated that Mobuck Holdings purchased land south of Birchwood and the condo association received a letter from Mobuck Holdings informing them that the lease road used by Birchwood residents now owned by Mobuck Holdings will require that anyone travelling on the road purchase a permit at a cost of \$2500. The letter indicated that Mobuck Holdings will allow emergency access without a permit but must be notified following the use of the road for emergency purposes. The delegation was asking who owns the right of way on RR55 and if the County could provide the condo with assistance in this matter.

The Birchwood delegation also voiced their concerns with the garbage and debris left by the owners of the Birchwood Golf Course. Alberta Environment advised them the bridge couldn't be removed because of fish spawning, however that season has come and gone and the bridge is still there. The delegation asked if the County had any jurisdiction to have the owners clean up the mess and what is happening with the clubhouse as it is full of black mold.
